8. Educational Aims of the Programme: [Adult Nursing]

The overall aim of the Programme is to enable Award holders to register with the Nursing and Midwifery Council Register of Nurses as a Registered Nurse, Adult Nursing. Within this context, the educational preparation will develop nursing competence through:

- i) the promotion of development of the personal and professional skills for the student to be competent to undertake the role and responsibilities of a registered adult nurse, as identified by the NMC (2004)
- ii) the promotion of the potential for higher order thinking whether in informal thought or embodied in professional action, including the ability to undertake a lead role in professional practice
- iii) the development of the potential for critical reflection on knowledge and experience in relation to the wider social economic issues that affect health care, welfare and life style
- iv) the development of the ability to review and evaluate the principles underpinning professional practice as an adult nurse and establish a professional identity (NMC 2004)
- v) the facilitation of experiences and knowledge of multi-professional teamwork and collaborative working practices, including partnerships with service users and carers
- vi) ensuring that all statutory requirements are met in order to obtain registration on the NMC Register of Nurses (Registered Nurse, Adult Nursing)
- vii) the development and rehearsal of interpersonal skills
- viii) the development of adult branch-specific knowledge and skills.

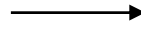

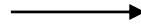
