



Taking account: households, finance and distribution

A workshop exploring current challenges for the System of National accounts

University of Greenwich, Hamilton House (HH102), 21st November 2018

The System of National Accounts (SNA) is the primary data framework for macroeconomists and economic policy makers. Recent years have seen discussions on how to improve the SNA and attempts to broaden the set of available aggregates and data series. This reflects awareness that the use of standard macro aggregates may not be appropriate for all research and policy questions. One area of activity relates to the longstanding issue of the use of imputations in the national accounts. This introduces difficulties in reconciling aggregate data and household surveys (Cynamon and Fazzari 2015, Davies et al. 2016) as well as raising conceptual issues around the appropriate measure for a particular task: quantifying economic well-being requires different aggregate measures than estimation of cash-flow measures of effective demand. Another area of focus is development of the links between national accounts and financial accounts in order to improve the understanding of how financial and real interactions play out in an economy (Mason and Jayadev 2014, Zhang 2015, Thomas and Nolan 2016). Finally, increasing attention to distributional issues has led to attempts to produce datasets allowing for a consistent household level breakdown of national aggregates such as household disposable income and consumption expenditures (Piketty et al. 2018, Tonkin 2015).

This workshop aims to bring together researchers from academia and national statistical agencies who work on these or related topics to discuss and exchange ongoing research in an informal setting. The goal is to inform the development of new statistical measures and explore opportunities for potential future collaboration.

This workshop is organised by the Foundation for European Progressive Studies and Greenwich Political Economy Research Centre at the Institute of Political Economy, Governance, Finance and Accountability/University of Greenwich. The workshop received funding from the European Parliament.
